
NAWGJ UTAH JUDGES HANDBOOK

To our new judges or interested individuals:

We want to welcome each of you who are considering becoming a Utah State Gymnastics Judge! Whether you are a new judge, new to our state, or even considering the idea of becoming a judge, we are here to aid and support you! Do not hesitate to contact Heather Carmody (hlacruey@yahoo.com), our Utah State Judging Director (SJD), for more information. Nanette Walker (nanawalk@hotmail.com), a member of the NAWGJ Utah board, is our New Judge Trainer/Mentor, and is responsible for organizing continuing judge education opportunities and judging clinics for all judges in Utah. She will be happy to assist with test preparation, judge training and support, and answer questions involving judging issues.

Items to Consider Before Becoming a Judge:

Pros:

1. Great way to stay involved in the sport
2. You get paid! Refer to USA gymnastics Rules and Policies (Chapter 5) for judge's current compensation package. [Click here to download the 2017-18 Rules & Policies](#) - Updated 8/23/17
3. Judging gymnastics is fun! You get to sit and watch mostly beautiful gymnastics all day!
4. You meet great people. Judging can create life-long friendships!

Cons:

1. **High start-up cost!** There are many costs and memberships that are involved into becoming a judge before you will ever be assigned a meet. You will need to complete all the following registrations before ever being on the floor of a gymnastics competition:
 - [USA Gymnastics Membership](#) – \$89 yearly
 - [NAWGJ Membership](#) – \$60 yearly
 - [Safety Certification](#) – \$65 (must re-certify every 4 years)
 - [Background Check](#) – \$21.25 + (must re-certify every 2 years)
 - Purchase printed copies of the JO Compulsory (\$60), Xcel (\$40), and JO Optional (\$60) Code of Points: \$60 for each Code of Points. <http://usagym.sportgraphics.biz/c-17-rules-jo-materials.aspx>

 - CPE (Continuing professional education)-Judges are required to complete CPE based on judges rating every year. You do not get paid for attending CPE clinics and they usually cost money. Clinics and conferences can be fun though! You are with your judging friends! For more explanation, refer to chapter 5 in Rules and Policies. - Gymnastics meets are on weekends! Once you state you are available for a specific weekend you cannot back out!
- Scheduling is usually done based on seniority and location.
- Retesting is every 4 years for Optional Rating & every 8 years for Compulsory Rating

***Now you know the Pros and Cons about judging gymnastics. The next step is learning what is required to become a judge.**

How to become a Judge: [Judging Overview & Continuing Professional Education Requirements](#)

1. One can earn a rating as a gymnastics official through a series of exams, both Written and Practical, administered under the auspices of the USA Gymnastics Judging Accreditation Program.
2. It is recommended that interested individuals attend local judging clinics and/or Regional Congresses that cover compulsory and/or optional gymnastics to develop the basic knowledge and skills required to become a judge.
3. It is recommended that you contact your NAWGJ (National Association of Women's Gymnastics Judges) State Judging Director for information about upcoming clinics, exams dates, etc. It is very helpful to attend a judges' training clinic prior to taking judging tests. 4. To officiate women's gymnastics under USA Gymnastics Junior Olympic rules, judges must have knowledge of the rules and regulations included in the following publications (and addendums):

5. Memberships/Certification requirements:
 - Must be a current Professional Member of USA Gymnastics: \$89 yearly [Professional](#)
 - If under the age of 18, must be a current Junior Professional Member of USA Gymnastics; and must upgrade to a Professional Membership upon turning 18: \$89 yearly [Junior Professional](#)
 - NAWGJ Membership: \$60 yearly [NAWGJ Membership](#)
 - Must hold a current safety certification. [U101: Safety & Risk Management](#) \$65 (must re-certify every 4 years)
 - Must pass a criminal background check (if 18 yrs. or over) [Background Check](#) – \$21.25 + (must re-certify every 2 years)
 - Safe Sport: Currently Free! [U110: USOC SafeSport](#)

Judge Rating Guidelines:

1. Any individual that has never held a rating may test at Compulsory Level 4/5 and/or at the Optional Level 7/8.
2. Individuals may choose to become rated for optional levels only. A Level 4/5 rating is not required.
3. The Accreditation year will be defined as August 1-July 31.
4. Test sessions will be scheduled within the USA Gymnastics Judging Accreditation Program by individual Test Administrators. A master list of all upcoming testing sessions, the test parts to be offered at each, and information on how to register for a test can be found on-line under [Judges Accreditation/Master Testing Schedule](#).
5. Examinees may take the written and/or practical exam for a specific level a maximum of four (4) times per accreditation year in the attempt to pass.
6. Ratings Overview:

1. Compulsory Level 4/5:
 - Must be a minimum of 16 years of age
 - Must take a 50-question multiple choice written exam and achieve a minimum score of 70%. (10 questions on General Info, 10 on Vault, and 5 questions on UB, BB & FX for each of the two levels)
 - Once a rating is achieved, the 4/5 judge is certified to judge USA Gymnastics Junior Olympic Compulsory Levels 1-5.

2. Optional Level 7/8:
 - Must be a minimum of 16 years of age.
 - Must take a 50-question multiple choice written exam covering both Level 7 and 8 and achieve a minimum score of 70%. (5 questions per level on general, vault, UB, BB and FX)
 - Must take a practical (video) exam showing **Level 8 exercises only** and achieve a minimum score of 70%. (One practice routine plus 5 exam routines per event).
 - Examinee is not required to take both parts at the same time, nor are they required to repeat any part previously passed within a four-yr. cycle beginning the year after the Olympic year.
 - Must pass the compulsory 4/5 test in order to also earn a Compulsory rating.
 - Once a rating is achieved, judge is certified to judge USA Gymnastics Junior Olympic Optional Levels 6, 7 and 8.

3. Optional Level 9:

- Must have held an Optional Level 7/8 rating for a minimum of twelve (12) months. Judges are allowed to take this exam if they are within one month of the anniversary of the date they passed the Level 7/8 exam.
- Must meet the Continuing Professional Education (CPE) requirements of 12 hours (minimum 6 clinic hours).
- An exception to the above (2) requirements will be made for any former or present Level 10 or Collegiate Regional coach, or Regional NCAA or Level 10 senior gymnast. Those qualified individuals may begin testing at Level 4/5 and Level 9 concurrently. Level 10/Collegiate coaches and eligible athletes must complete an Exemption Eligibility Form. [Women's J.O. Exemption/Eligibility Form](#) A USA Gymnastics National, Regional or State officer (or collegiate coach) must sign off on this form prior to testing. This form must be brought to the test site and given to the Test Administrator prior to administration of the test.
- Must be a minimum 18 years of age.
- Must take a 50-question multiple choice written exam and achieve a minimum score of 76%. (7 questions on General and Vault, 12 questions each on UB, BB and FX)
- Must take a practical (video) exam and achieve a minimum score of 75%. (One practice routine plus 5 exam routines per event).
- Examinee is not required to take both parts at the same time, nor are they required to repeat any part previously passed.
- May achieve a Level 7/8 rating provided that the minimum score of 70% is met on both test parts.
- Once a Level 9 rating is achieved, judge is certified to judge USA Gymnastics Junior Olympic Optional Levels 6, 7, 8 and 9.
- Must pass the compulsory 4/5 test in order to earn a Compulsory rating.

4. Optional Level 10:

- Must have actively held an Optional Level 9 rating for a minimum of twelve (12) months. Judges are allowed to take this exam if they are within one month of the anniversary of the date they passed the Level 9 exam.
- Must meet the Continuing Professional Education (CPE) requirements of 16 hours (minimum 8 clinic hours).
- An exception to the above (2) requirements will be made for any former or present Elite Coach or Senior Elite gymnast who participated at a National Elite Classic or Championships. Those qualified individuals may begin testing at Level 4/5 and 10 concurrently. Elite Coaches and eligible athletes must complete an Exemption Eligibility Form. [Women's J.O. Exemption/Eligibility Form](#)
- A USA Gymnastics National, Regional, or State officer must sign off on this form prior to testing. This form must be brought to the test site and given to the Test Administrator prior to administration of the test.
- Must be a minimum of 20 years of age.
- Must take both a practical (video) and written exam. Must receive a minimum score of 80% on each examination part. Examinee is not required to take both parts at the same time, nor are they required to repeat any part previously passed.
- May achieve a Level 9 rating provided that a minimum Written exam score of 76% and a minimum Practical exam score of 75% are both met.
- May achieve a Level 7/8 rating provided that a minimum score of 70% is met on both test parts.
- Once a Level 10 rating is achieved, the judge is certified to judge USA Gymnastics Junior Olympic Optional Levels 6, 7, 8, 9, and 10.
- Must pass the compulsory 4/5 test in order to earn a Compulsory rating.

5. Brevet and National Judges:

- Must attend a Brevet or National Judges' Course, **by invitation only**. These courses are conducted every four years - the second year following each Olympic year.
- Must successfully pass all the requirements of the course. [2017 National Judge Course Eligibility Form](#); [2017 USA Brevet Judge Course Eligibility Form](#)
- Are certified to judge all Junior Olympic Optional Levels 6, 7, 8, 9 and 10.
- Must pass the compulsory 4/5 test in order to earn a Compulsory rating.

- Any judge with a Level 10 or above is eligible to judge NCAA gymnastics

6. Practice Judging Requirements must be completed before judging a new level. Practice judging sessions will be schedule by the board, and must be met before you are assigned to judge a meet. You are more than welcome to take advantage of additional practice sessions, since feedback from your practice judging sessions will determine your readiness for a judging assignment. We want you to be confident in your skills **before** you're assigned to your first competition at any level.- [Practice Judging Form](#)
 - One in-gym 2-hour practice judging session with an experienced judge.
 - One Practice Judging Session/Level at a USAG Sanctioned Competition (MUST rotate to all 4 events for each new level)
7. GymJas - (The Judging Assigning System for Utah) After you've become a member of the NAWGJ and USAG, completed your Safety Certification and Back Ground Check, read the Code of Professional Responsibility, and met all the practice judging requirements for your rating, you can register and enter your personal information, and judging availability in [GymJas](#). If you are not in the system, you will **NOT** be assigned to any meets. It is your responsibility to keep your availability, and personal information current in GymJas. If you test up and receive a new rating, **YOU** will need to change it in GymJas, so the assigner knows which levels you can be assigned to judge.

Uniform:

1. Uniform information can be found on the [NAWGJ website here](#). It might be advantageous to try and existing judges jacket on for sizing before purchasing. Lands End is the official supplier of NAWGJ uniforms, however, a great place to buy comfortable professional looking navy blue slacks is through [Donalds Uniform](#). The slacks are called Tribal Dress pants – Yoga Style.
2. The official uniform is not required when you first begin judging. In Rules and Policies, the dress code is as follows:
 - Navy Skirt or pants and jacket with a white blouse. There is nothing stated about footwear. (Heels are discouraged because they can damage gymnastics mats) Business appropriate attire is suggested. Make sure your clothes are clean and you look professional!

Continuing Professional Education (CPE) Requirements: [Judging Accreditation Forms](#)

1. Annual CPE credits are required to be assigned to USA Gymnastics sanctioned events.
2. CPE credits will be calculated in actual clock hours.
3. Accreditation year is August 1 – July 31. Credits earned during the months of June and July may be used for the current or upcoming accreditation year.
4. Required CPE hours are as follows:

5. Clinic CPE credits will be defined as hours spent at a State, Regional, or National organized events such as Congresses, Clinics, Courses, or Symposiums. These events must be publicized in advance and open to all judges in the state, region, or nation as applicable to the event (Exception: eligibility requirement must be met for National/Brevet judges' courses.) USA Gymnastics University will develop CPE certificates to be issued at the conclusion of an (clinically) approved session by the Clinician or organizational personnel.
6. Clinical Activities will be designated as "Approved for CPE" by the following:
 - National- USA Gymnastics National Office
 - Regional- USA Gymnastics Regional Technical Committee Chairman (or designee)
 - State- USA Gymnastics Regional Technical Committee Chairman (or designee)
 - Those wishing to have a clinic approved for CPE simply need to send the CPE Clinic Approval form to their respective State Administrative Committee Chair or Regional Technical Chairman and respective NAWGJ Director with the date and topic(s) of the clinic(s), anticipated attendance, and name(s) of the clinician(s). The appropriate officers will sign the form and the Clinic Organizer will forward it to the National office to the attention of the Women's JO Technical Director. CPE clinics will be posted on the website under [Women/Judges](#).

7. A maximum number of CPE hours may be acquired for the following miscellaneous activities:
 - Coaching (6 hours); to be signed by supervisor or club owner
 - In gym observation, critiquing/consulting (voluntary) with coaches and gymnasts (6 hours); to be signed by the coach.
 - Volunteering at a judging-related activity (4 hours); to be signed by the event coordinator. Two of these four hours can come from service as a USA Gymnastics Committee or NAWGJ Board member.
 - Video or live practice judging at a level equal to or higher than your current rating (3 hours); to be signed by the supervising judge. Practice judging will require pre-approval from your USA Gymnastics State Chairman or NAWGJ State Judging Director. For pre-approval, simply send an e-mail to the appropriate officer requesting permission. Please note that live Practice Judging will also require pre-approval from the Meet Director. This is done by contacting the Meet Referee for the competition; not by contacting the Meet Director directly. The practice judge should come prepared with all judging materials and wear the appropriate judging uniform. Video Practice Judging will be recorded in hours and requires written verification from the supervising judge.
8. Miscellaneous CPE activities should be recorded on CPE cards.

Continuing Professional Education (CPE) Tracking:

1. Each judge is responsible to keep accurate records of their CPE, including documentation of attendance at approved CPE experiences. Documentation should correspond to the hours submitted on the Annual CPE Record Form. [CPE Cards](#); [Clinic Hours for Multi-Track Educational Events Form](#)
2. Each judge is responsible for recording a summary of their total annual CPE hours by category, recorded on the Annual CPE Record Form ([Annual CPE Record](#)), and submitting their form to their respective CPE Coordinator, by May 31 of each year. Jenny Diamond (jennydiamond19@gmail.com) is the CPE Coordinator for Utah. She will send a CPE Report to Heather Carmody (SJD) listing all the judges in the state, the number of CPE hours they complete each year, and the number of clinical hours they will carry forward to the next year,
3. Heather Carmody (SJD) is responsible to send a master list of all judges who have successfully completed their annual CPE requirements to the USA Gymnastics National Office (JO Technical Director), the respective RJD, and the respective USA Gymnastics State and Regional Administrative Committee Chairman by June 30.
4. If a judge does not complete all of their required CPE hours within a given year, they must apply CPE hours from the successive year to make up for the hours they were lacking. When completed, they must still send the proper documentation to their CPE Coordinator. Note that CPE hours cannot be used twice, meaning, if hours are being used to make up from a previous year, those same hours could not be applied to the current year as well. **Any judge who has not completed their CPE requirements before the start of the next season will not be assigned to judge unless in the case of an emergency, in which case they will be paid \$5 less per hour.**
5. The National Office will conduct audits each year in October or November that will require randomly selected judges to provide actual documentation of the CPE, as reported on the Annual CPE Record Form to their CPE Coordinators, **it's important to keep your CPE documentation!**
